3	CHAIRMAN LEVI: Can we have a motion to
4	approve the agenda?
5	MOTION
6	PROFESSOR KECKLER: So move.
7	CHAIRMAN LEVI: Second?
8	MS. MIKVA: Second.
9	CHAIRMAN LEVI: Okay. All in favor?
LO	(A chorus of ayes.)
L1	CHAIRMAN LEVI: We've been sent a draft of a
L2	request for proposals for executive search firms. And
L3	are there any comments, changes, issues with the draft
L4	proposal?
L5	MR. MADDOX: My only comment, John Victor
L6	Maddox here is I thought the proposal was well done,
L7	and I fully support it.
L8	MR. STEIN: I have one question. Might the
L9	proposal include a time frame from the date of award to
20	when it is expected to be completed? I may have missed
21	it, but I didn't see that.

MS. COHAN: It's on page 5. There's a space

- 1 for it to be filled in.
- 2 CHAIRMAN LEVI: It's on page 5.
- 3 MS. COHAN: It needs to be filled in.
- 4 MR. STEIN: On page -- oh, then I didn't get
- 5 it. Okay.
- 6 CHAIRMAN LEVI: And that's something we can
- 7 discuss today. And in fact, that was, I think, the only
- 8 place that we did have.
- 9 So what do you think is realistic? Thirty
- 10 days?
- MS. WEIR: Thirty days, from what point to
- 12 what?
- CHAIRMAN LEVI: Well, we want the -- do we
- want proposals back within 30 days? Is that realistic,
- 15 folks? I think it is.
- MS. WEIR: I do.
- 17 CHAIRMAN LEVI: And the question is -- or is
- 18 that too much? Do you want to make it 21 days? I think
- 19 30 days is probably more reasonable.
- MR. MADDOX: That seems fine.
- 21 MR. STRICKLAND: In this market, I'll bet you
- 22 you can shorten the time and get responses from anybody

- 1 who's interested. But I certainly -- 30 days is okay,
- 2 but I'll get you could get a shorter time.
- 3 DEAN MINOW: Make it 28 days.
- 4 CHAIRMAN LEVI: Let's see. Today is --
- 5 MR. FORTUNO: The 27th.
- 6 CHAIRMAN LEVI: Why don't we say by May --
- 7 MR. STRICKLAND: May 28 is the end of the --
- 8 CHAIRMAN LEVI: Well, May 28th is Memorial Day
- 9 weekend. So why don't we say Monday, May 24th?
- 10 MS. WEIR: Memorial Day weekend, yes, that's a
- 11 bad one.
- 12 CHAIRMAN LEVI: Why don't we try for Monday,
- May 24th? How about that? That's 28 days.
- 14 DEAN MINOW: That sounds good.
- MR. STRICKLAND: Good.
- MS. WEIR: I'm fine.
- 17 CHAIRMAN LEVI: And then I think the proposals
- should probably be -- will anybody know if they're
- 19 directed to me in this building, or should we have them
- 20 sent to you, Vic?
- 21 MR. FORTUNO: It's up to you. We can have
- 22 them sent directly to you, if you'd like, or they --

- 1 CHAIRMAN LEVI: Well, you're going to send
- 2 them to the committee.
- 3 MR. FORTUNO: What I would do -- yes. Either
- 4 me or to the corporate secretary, who can then, just as
- 5 a matter of course, distribute them to everybody. But
- 6 it's --
- 7 CHAIRMAN LEVI: Yes. I think have them
- 8 directed to you.
- 9 DEAN MINOW: Let's just eliminate any extra
- 10 step. If the corporate secretary is going to send them
- out, then just have them sent there.
- 12 MR. FORTUNO: Okay. Corporate secretary.
- 13 PROFESSOR KECKLER: The only question I would
- have is whether or not you're contemplating having an
- initial screen of the proposals for compliance with the
- 16 RFP before we evaluate them.
- 17 CHAIRMAN LEVI: Yes. That's why I think they
- 18 should come to you.
- MR. FORTUNO: All right.
- 20 CHAIRMAN LEVI: I think they should come to
- 21 Vic.
- DEAN MINOW: Okay. But then, if that's going

- 1 to come up against the deadline, I mean, I don't know
- 2 how you're going to handle that, Vic.
- 3 MR. FORTUNO: What I was -- yes. What I was
- 4 thinking was if I get them, just to send those that meet
- 5 the requirements set out in the RFP; but to send you a
- 6 memo that explains which others were received and why
- they weren't forwarded, where they fell short, so that
- 8 you were at least aware of everything that was received.
- 9 But that will take a day or two. Assuming
- 10 that they all come in fairly close to the deadline, you
- 11 probably won't get this until right after the Memorial
- 12 Day weekend.
- 13 CHAIRMAN LEVI: Well, that's --
- DEAN MINOW: I mean, that's my question. I
- think you're right. There may be none until just at
- that end. But if there are some coming in, I'd like to
- 17 have them as they come in.
- 18 DEAN MINOW: Oh, sure. We can do that.
- 19 CHAIRMAN LEVI: We're going to do that.
- MR. FORTUNO: Yes.
- 21 CHAIRMAN LEVI: And then, traditionally, we
- 22 can send these out to a whole group, or we can also make

- 1 sure we include that the Corporation has used previously
- and successfully, and any names or firms that anyone on
- 3 the call wants to suggest. I think it should be
- 4 generally available on our website.
- 5 MS. WEIR: This is Deierdre. One of the
- 6 questions I had is do we have a list presently of search
- 7 firms we're going to send it out to?
- 8 MR. FORTUNO: The Corporation has used in the
- 9 past two firms that I'm familiar with. One is Heidrick
- 10 & Struggles. Frank, the firm -- the board that you
- 11 chaired used Heidrick, didn't it?
- 12 CHAIRMAN LEVI: Yes.
- 13 MR. STRICKLAND: Yes, we did. And we also
- 14 contacted --
- 15 CHAIRMAN LEVI: And Isaacson, Miller.
- 16 MR. STRICKLAND: -- two other firms. One was
- 17 called Korn/Ferry, K-o-r-n, Korn/Ferry.
- 18 CHAIRMAN LEVI: Right.
- 19 MR. STRICKLAND: And the other one -- Vic,
- 20 help me with this one -- it's in Boston.
- MR. FORTUNO: Isaacson, Miller.
- 22 CHAIRMAN LEVI: Isaacson, Miller.

- 1 MR. STRICKLAND: Yes.
- CHAIRMAN LEVI: Now, Martha, you had a name,
- 3 also.
- 4 DEAN MINOW: Yes, I do. So do we send -- we
- 5 actually do send this out to actual firms, as opposed to
- 6 simply post it somewhere?
- 7 CHAIRMAN LEVI: Yes. We do both.
- 8 DEAN MINOW: I see. So I would suggest
- 9 sending it to -- I'll send you the name. It's here in
- 10 Wilcox, an IM Search.
- 11 CHAIRMAN LEVI: There's also a big legal
- 12 search firm -- I believe they're still in business --
- 13 Major, Africa and --
- MS. COHAN: Hagan?
- 15 CHAIRMAN LEVI: Yes. But I think, in the
- interests of the public here, that it ought to be posted
- 17 on the website and available with some note that --
- 18 MR. STRICKLAND: John, we're having trouble
- 19 hearing you.
- 20 CHAIRMAN LEVI: I said I think it should be
- 21 posted on our website and made more generally available
- in some published way.

- 1 MR. FORTUNO: We can probably issue a press
- 2 release that won't get too much coverage, but at least
- 3 it's out there in addition to being on our website, and
- 4 of course, target any firms whose names are submitted to
- 5 us by members of the search committee or advisory
- 6 committee members. And we can go ahead and send out to
- 7 specific firms whose names we get from you.
- 8 So that should give us a pretty good turnout.
- 9 I think it's a limited universe of prospects here, and
- 10 I think we're probably able to identify a good half-
- 11 dozen to a dozen. And then the posting on our website
- and issuing a press release may possibly generate
- another one. But I suspect that the universe is going
- to be relatively small.
- 15 CHAIRMAN LEVI: Any other --
- MR. STRICKLAND: To start with, it has to be
- 17 somebody who does work in the nonprofit area --
- 18 CHAIRMAN LEVI: Right.
- 19 MR. STRICKLAND: -- it seems to me, just to be
- 20 familiar with that market.
- 21 CHAIRMAN LEVI: Right.
- DEAN MINOW: The one I'd mentioned -- it's

- 1 Martha again -- is Isaacson, Miller.
- 2 CHAIRMAN LEVI: Yes. We are sending there.
- 3 DEAN MINOW: It's probably too expensive to
- 4 put an ad in the Chronicle of Philanthropy, but it would
- 5 be great to get a story in there, which doesn't cost
- 6 anything.
- 7 CHAIRMAN LEVI: That's a great suggestion.
- 8 MR. FORTUNO: In fact, I'll have Steve Barr
- 9 look into that right now.
- 10 CHAIRMAN LEVI: And see if there's any other
- 11 like journal. If we don't get sufficient proposals, we
- 12 can always extend the date. But I hope we can get some
- 13 competition here.
- Any other issues on that? Are we good?
- MR. STRICKLAND: I have one or two
- 16 typographical suggestions in the notice itself, if I
- 17 might --
- 18 CHAIRMAN LEVI: Yes, please.
- 19 MR. STRICKLAND: -- cover those. On page 3,
- 20 under paragraph B, "for ensuring a diverse applicant
- 21 pool." Mine shows "an diverse applicant pool."
- 22 MS. COHAN: I'm sorry. Can you repeat what

- 1 page that was?
- 2 CHAIRMAN LEVI: Page 3.
- 3 MR. STRICKLAND: Did you get that one?
- 4 CHAIRMAN LEVI: No. I don't think she's found
- 5 it.
- 6 MS. COHAN: No.
- 7 MR. FORTUNO: What's the heading?
- 8 CHAIRMAN LEVI: Somebody's really --
- 9 MS. COHAN: Paragraph B?
- 10 MR. STRICKLAND: I'm not hearing you guys.
- 11 CHAIRMAN LEVI: Somebody's breathing heavily
- into the phone. If they can back away from it just
- 13 slightly. Okay. Yes.
- MS. COHAN: Oh, I got it. Thank you.
- 15 CHAIRMAN LEVI: Next one, Frank.
- MR. STRICKLAND: Okay. And then -- let's see
- if I can find them. Bear with me one minute here.
- 18 Okay. I guess at the bottom of page 1, third line from
- 19 the bottom, I would suggest a small "i" in the word
- 20 "interim."
- 21 CHAIRMAN LEVI: Okay. That's through.
- 22 MR. STRICKLAND: Okay? Those are all my

- 1 corrections.
- 2 CHAIRMAN LEVI: Any other changes?
- 3 MS. WEIR: This is Deierdre. I just have a
- 4 question. At the top of page 5, where it talks about --
- 5 No. V(A), it talks about providing copies, and it says
- 6 five. Will the advisory committee members get a copy of
- 7 the proposals?
- 8 CHAIRMAN LEVI: Yes.
- 9 MS. COHAN: Yes. So we can either ask people
- 10 to provide more copies or we can make them.
- 11 CHAIRMAN LEVI: We'll make the copies, or we
- 12 may e-mail them to you. More likely we'll PDF them.
- MS. COHAN: Yes.
- MS. WEIR: Okay.
- MS. COHAN: My only question is there were
- 16 some other dates. Do you want to put target dates in or
- 17 not?
- 18 CHAIRMAN LEVI: I think, at this juncture, we
- 19 need to be guided by them.
- MS. COHAN: Okay.
- 21 CHAIRMAN LEVI: I'd like to see what they
- 22 propose rather than proposing it for them.

- 1 MR. STRICKLAND: To minimize our own staff
- work, it could be we ought to take a head count of the
- 3 number of people on the committee and others, and
- 4 request that many copies of the proposal. It's not
- 5 uncommon for them to put these in a ring binder. What
- 6 does everybody else think?
- 7 CHAIRMAN LEVI: Well, this is just the
- 8 proposal, Frank. This is just the proposal from the
- 9 search firm, not ultimately what they do when they've
- 10 got candidates and they're sending out. Then we'll want
- 11 a book for everybody.
- 12 MR. STRICKLAND: Right.
- 13 CHAIRMAN LEVI: Okay? But this is just for
- the proposal from the search firm. And I think we'll
- probably PDF that around to people.
- MR. STRICKLAND: Okay.
- 17 MR. JEFFRESS: Have them mail it
- 18 electronically to you.
- 19 CHAIRMAN LEVI: Well, that's what we'll
- 20 probably do.
- 21 A couple of other things that I want to say on
- 22 the front end here. Occasionally we'll have to have an

- 1 executive session, maybe. I don't know whether we will.
- 2 But if we do, an executive session, in my vernacular,
- 3 means the five people who are the voting members.
- 4 More often than not, because we're not going
- 5 to be actually deliberating and deciding anything, we
- 6 will have closed session of the search committee when we
- 7 have to, and that includes the five advisory members.
- 8 When we have to have a public session because we need to
- 9 decide something, then we will announce those in the
- 10 Federal Register and we'll agree on a calendar. But
- 11 that's going to take some time as we ramp up the search.
- 12 So I do want to be mindful of people's
- 13 schedules and travel and try to figure out ways in which
- 14 we can have these search meetings by phone more often
- 15 than not. But if some of you happen to be -- if we set
- it up correctly, maybe a few of you will at the in
- 17 Chicago at some point because Laurie and I are there.
- 18 Martha's going to be there on the 10th of May.
- 19 I'm thinking if maybe we get some response by
- then, we could have a shot call just to say, here's
- 21 where we are and here's where we aren't. And after
- 22 that, we'll come up with a schedule that tries to take

- advantage of our board minutes and people's whereabouts.
- 2 Any other public comment? I guess actually we
- 3 didn't consider and act on the draft. Maybe I need a
- 4 motion to approve it and --
- 5 MOTION
- 6 DEAN MINOW: So moved.
- 7 CHAIRMAN LEVI: Second?
- 8 MR. MADDOX: Second.
- 9 CHAIRMAN LEVI: In favor?
- 10 (A chorus of ayes.)
- 11 CHAIRMAN LEVI: Okay. It carries.
- 12 Any further public comment, since I made the
- public comment before the motion?
- 14 MR. DE LA TOUR: Public comment about the
- 15 motion or in general?
- 16 CHAIRMAN LEVI: In general.
- 17 MR. DE LA TOUR: Can everyone hear me all
- 18 right?
- 19 COMMITTEE MEMBERS: Yes.
- 20 MR. DE LA TOUR: Good. My name is David de la
- 21 Tour. I've worked at LSC for 22 years. I'm currently
- one of the interim elected union leaders. And the

- 1 membership asked me to call and participate in this
- 2 meeting today to make you all aware of a couple of brief
- 3 things regarding the search process.
- 4 And we recognize that you all -- we welcome
- 5 the new people again. We recognize you all are here
- 6 quickly and moving fast, and that we have a pending
- 7 request just to talk about a few things, and that we
- 8 haven't all had time yet to do that. This was one of
- 9 those things.
- 10 It is a very strong belief on behalf of the
- 11 majority of staff that it would be in LSC's best
- interests to add an advisory committee member who is a
- representative from or of the union. We recognize in
- 14 the resolution that it says that no one should be an LSC
- 15 staff person.
- We did some research on that and found that
- 17 that was a policy that was adopted by LSC. We really
- 18 didn't find whether that was a prohibition. However,
- 19 what we wanted to also let you be aware of is that if
- that were indeed something you wanted to stay with, we
- 21 could have a person who's not an employee represent the
- 22 union as one of the advisory members.

- 1 And we think that this would be something we
- don't expect you to decide right now, but we'd like you
- 3 to seriously consider. Okay? Thank you very much.
- 4 CHAIRMAN LEVI: Any other public comment?
- 5 (No response.)
- 6 CHAIRMAN LEVI: I will make an initial
- 7 reaction, even though I will take the --
- 8 MR. MADDOX: John, I'm sorry. I cannot hear
- 9 you.
- 10 CHAIRMAN LEVI: I wonder why we can hear David
- 11 de la Tour? Isn't he in the same building? Can you
- 12 hear me now?
- MR. MADDOX: That's better.
- 14 CHAIRMAN LEVI: Well, I'm right up against
- this, leaning over the -- all right. I have conducted
- searches in prior iterations where there were unionized
- members of the faculty.
- 18 And the search committee -- you know, normally
- 19 a search is done by the board, and there are appropriate
- 20 ways for employees to have input through the process of
- interviewing and when candidates are being selected.
- 22 And the search firm itself, in my view, has a

- 1 responsibility to talk to people in the building
- generally. But it would be -- it's fairly unusual to
- 3 have membership of that kind on a search committee.
- 4 I should also say that at the moment, we have
- 5 five advisory members and five board members. And to
- 6 me, the notion of having -- I think that's a nice
- 7 balance.
- 8 But that's my initial impression, but I will -
- 9 and I'm sure the rest of my colleagues on here may
- 10 have a reaction or two. We'll take it under advisement,
- 11 but that's my --
- 12 MS. MIKVA: Mr. de la Tour? This is Laurie
- 13 Mikva speaking. I'm wondering whether the union could
- 14 give us some suggestions for how you could have input
- other than being on the search committee. I think that
- might be helpful in the event that the decision is made
- not to add one of you to the advisory panel.
- 18 MR. DE LA TOUR: We would be welcome to do
- 19 anything that would facilitate more open communication.
- 20 However, we don't know enough about the process, I
- 21 believe. I'll take that back to the membership, but I'm
- 22 not sure we know enough about the process right now to

- 1 know how we co.
- Now, I just heard a suggestion about
- 3 interviewing. That would be brand-new for LSC.
- 4 Typically, people have just been sprung on staff, and I
- 5 think that -- and in great secrecy, as well. So I think
- 6 anything that would be more open that would involve
- 7 staff in the process, again, would be to the benefit of
- 8 LSC because, as you all learn what has been occurring, I
- 9 think that we're all looking for different leadership.
- 10 The other thing I just should mention, and it
- is a common belief of staff, is that because the
- 12 advisory committee includes persons outside of LSC, that
- makes people feel even moreso that the staff of LSC
- 14 should be somehow included formally in the process.
- 15 CHAIRMAN LEVI: Well, I guess historically --
- we're observing a sort of historical precedent here,
- 17 that the ABA committee and NLADA have had
- 18 representatives on the search committees for LSC prior
- 19 to this time. And that's --
- 20 MR. DE LA TOUR: And we have no problem with
- 21 that, yes. But we believe that's even moreso a case for
- 22 people working at the Corporation to have a voice as
