- 1 PROCEEDINGS
- (4:02 p.m.)
- 3 CHAIRMAN LEVI: Let's call the meeting to
- 4 order. This is the duly noticed meeting of the
- 5 Institutional Advancement Committee of the Legal
- 6 Services Corporation.
- 7 Can I have a motion to approve the agenda?
- 8 MOTION
- 9 MR. KECKLER: So moved.
- 10 FATHER PIUS: So moved, and seconded.
- 11 CHAIRMAN LEVI: Any discussion?
- 12 (No response.)
- 13 CHAIRMAN LEVI: All in favor?
- 14 (A chorus of ayes.)
- 15 CHAIRMAN LEVI: Okay. Wendy, do you want to
- 16 lead us on this discussion?
- 17 MS. RHEIN: Sure. Hello, everyone. We will
- 18 be presenting very quickly an overview of several
- 19 different policies that will be available for you at
- 20 the next call so that you can review them in more
- 21 detail.
- 22 As we're setting up a development program,

- 1 there are some specific policies and procedures that we
- 2 want to have in place so that when we have finished the
- 3 state registration process, which is underway, that we
- 4 are ready to go, that we'll be able to start soliciting
- 5 for both individual as well as foundation gifts. And
- 6 as I said, part of that process of setting up the
- 7 foundation is establishing some policies and
- 8 procedures.
- 9 As you know, LSC has a gift acceptance
- 10 protocol already. One of the things that you'll be
- 11 receiving for the next call will be some proposed
- 12 additions to that particular policy that would allow
- 13 LSC to expand the types of gifts that it would receive,
- 14 including instituting a planned gift or an estate
- 15 bequest gift option, a gift of securities, art,
- 16 property, et cetera. So those will be proposed as
- 17 additions to that gift acceptance policy. That we'll
- 18 have for you at the next particular meeting.
- 19 Also, we had a discussion earlier about
- 20 confidentiality versus anonymity. We've been doing
- 21 some research regarding that here in the office, and
- 22 we'll be able to have a recommended policy on that for

- 1 you as well.
- 2 Also, there will be a policy on the acceptance
- 3 of memorial or honorarium gifts, and a donor bill of
- 4 rights. A donor bill of rights is a fairly
- 5 straightforward document. There are some templates
- 6 that have been developed by the Association for
- 7 Fundraising Professionals and other organizations
- 8 around the country.
- 9 That basically is a document that's available
- 10 on the organization's website that informs donors of
- 11 what they can expect from the organization, things
- 12 like, we will not sell your name to other
- 13 organizations. We will not provide your gift
- 14 information to entities outside of LSC or those that we
- 15 are legally required to report to, those kinds of
- 16 things.
- 17 Those are the policies that we'll have
- 18 available for you in more detail at the next particular
- 19 meeting so that you can respond to specifics about
- 20 those at that time.
- 21 Any questions or concerns?
- MR. GARTEN: Not here.

- 1 FATHER PIUS: Well, Wendy, this is all pretty
- 2 standard stuff and nothing out of the ordinary.
- 3 MS. RHEIN: It's very standard. Nothing out
- 4 of the ordinary at all. I think that the one position
- 5 that we're probably going to delve into more discussion
- 6 about is the issue of confidentiality versus anonymity
- 7 next week in response to the questions that you all
- 8 brought up in April at the board meeting.
- 9 So I think that that's the one particular
- 10 piece we'll probably have more conversation about. The
- 11 rest of it is very standard.
- 12 FATHER PIUS: Because I think the more,
- 13 especially big donors, see things that they're used to
- 14 seeing in fundraising, I think the more comfortable
- 15 they'll probably be, I would suspect.
- 16 MS. RHEIN: Yes. The bill of rights in
- 17 particular, as well as the gift acceptance policy that
- 18 includes these larger pools of funds that might include
- 19 stock gifts, all of those things, it's standard
- 20 language that both Atitaya and I have looked at from
- 21 several different organizations and from templates from
- 22 the Chronicle of Philanthropy, the Association of

- 1 Fundraising Professionals, and others.
- 2 It's boilerplate things we really just need to
- 3 have in place that provides some surety to a funder,
- 4 whether that be a foundation or an individual, that
- 5 you've done your due diligence.
- 6 CHAIRMAN LEVI: Other questions?
- 7 (No response.)
- 8 CHAIRMAN LEVI: So you're going to have things
- 9 to show us?
- 10 MS. RHEIN: We will have things to show you.
- 11 There are drafts with Jim that he and I will discuss
- 12 more this week, and then we'll have things for you to
- 13 review.
- 14 CHAIRMAN LEVI: Okay. Now, I suppose -- this
- is maybe slightly ahead of that piece, but related to
- 16 it, are we undertaking the process of becoming
- 17 registered in sufficient numbers of states that we can
- 18 begin a serious effort?
- 19 MS. RHEIN: Yes. We're doing these things
- 20 concurrently. So the policies and procedures we're
- 21 developing are happening concurrently to the state
- 22 registrations. We have a signed contract with a vendor

- 1 that has helped LSC before in state registrations, and
- 2 we're looking at 38 different states that we're going
- 3 to register in all at one time.
- The fees were very minimal, so we went ahead
- 5 and just made the commitment to do all of them at one
- 6 time so that the process is started and we'll be set to
- 7 go. So if you have a foundation that may be
- 8 headquartered in one city but writes a check from
- 9 another state, we want to make sure that we're covered
- 10 in all the bases.
- 11 CHAIRMAN LEVI: Yes. And when is that likely
- 12 to be --
- 13 MS. RHEIN: The process for the applications
- 14 could take around four to six weeks, according to our
- 15 contract. But then it's an issue of what we find from
- 16 there. Some of those are electronic filings; depending
- 17 upon the state, you get an answer right away, whether
- 18 your exempt or you have to pay \$25 to register. Others
- 19 that are paper filings may take a little bit longer to
- 20 hear back.
- 21 CHAIRMAN LEVI: So at this juncture, even as
- 22 we get these policies together, the only place that we

- 1 can actually appropriate seek funds is in the District.
- 2 Is that correct?
- MS. RHEIN: Yes. For at least the next four
- 4 to six weeks.
- 5 CHAIRMAN LEVI: Yes. Okay. Any questions?
- 6 Any more about this piece of the agenda?
- 7 (No response.)
- 8 CHAIRMAN LEVI: Public comment?
- 9 (No response.)
- 10 CHAIRMAN LEVI: Is there any other business?
- 11 (No response.)
- 12 CHAIRMAN LEVI: Now, are we having a closed
- 13 session today?
- MS. ROK: No. We don't have a closed session
- 15 scheduled.
- 16 CHAIRMAN LEVI: Okay. So I think the only
- 17 thing about other business is, I would suggest that the
- 18 timing of things -- Wendy, you and I have had this
- 19 conversation. So as we move along here, I think we
- 20 have to start to think about how to undertake the
- 21 creation of a calendar for the 40th year.
- 22 MS. RHEIN: Yes. And we have an initial

- 1 calendar. I know you have a meeting coming up that
- 2 will impact that calendar, so we have some different
- 3 potential ideas in place. And then hopefully by the
- 4 next call, we'll be able to have more of a concrete
- 5 calendar.
- 6 CHAIRMAN LEVI: And then the other question
- 7 that is related to that is that we also have -- from
- 8 Vic Fortuno, at least, I received -- I don't know. Did
- 9 everybody get what he dug out of the archives?
- 10 MS. RHEIN: Yes, they did.
- 11 MR. SMEGAL: I didn't.
- 12 CHAIRMAN LEVI: I'm sorry?
- 13 MR. SMEGAL: This is Tom Smegal. I don't
- 14 think I got it, no.
- 15 CHAIRMAN LEVI: Wendy, you got it from --
- 16 MS. RHEIN: I did.
- 17 CHAIRMAN LEVI: -- the 25th. And maybe we
- 18 should circulate that.
- MS. RHEIN: And the 30th.
- 20 CHAIRMAN LEVI: And the 30th?
- MS. RHEIN: Yes.
- 22 CHAIRMAN LEVI: I think that would be helpful

- 1 to circulate to the Committee.
- MS. RHEIN: Sure. I'm happy to do that. He
- 3 found the program and a CSPAN recording of the -- yes.
- 4 So we'll have several different things. I can forward
- 5 that to everyone.
- 6 CHAIRMAN LEVI: Yes.
- 7 MS. RHEIN: Some helpful background.
- 8 CHAIRMAN LEVI: Okay. Well, any other
- 9 questions? Comments? Issues? If you've heard of
- 10 people that are just chomping at the bit to give us
- 11 many millions of dollars, please let us know that, too.
- 12 And public comment?
- 13 (No response.)
- 14 CHAIRMAN LEVI: Any other business? Any good
- 15 jokes?
- 16 (Laughter.)
- 17 CHAIRMAN LEVI: All right. I hope you all had
- 18 a good Memorial Day weekend, and I'll entertain a
- 19 motion to adjourn.
- 20 MOTION

- 22 FATHER PIUS: So moved.
