Beginning in January 2006, the new Medicare Part D Drug Program is optional. It is available to anyone who gets Medicare and signs up. Premiums of about \$35. There is also a \$250 annual deductible and Iowans, however, will be eligible for "Extra Help"! This Extra Help in deductibles and co-payments. You can get Extra Help if you are getting benefits like Elderly Waiver, Medicaid for Employed Persons With Dis

You can also be eligible for Extra Help if you have low income and have annual income less than \$14,355. Countable assets must be less than \$11,000 for individuals and \$16,000 for couples. For 2005, annual income of less than \$19,245 and countable assets below \$2

Enrolling for Extra Help under the new Medicare Part D program is a

First, beginning July 1, 2005, you need to apply for Extra Help by contacting your local Iowa Department of Human Services office.

Second, you must select a Part D plan between November 15, 2005 and December 15, 2005. If you are not automatically enrolled in a Part D plan. If that happens, notice will be mailed to you. Details about the Medicare Part D program will be mailed to people and fall of 2005. If you are on Medicare but are not eligible for Extra Help, you may also contact your local Social Security or Iowa Department of Human Services at (800) 992-8161.

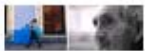

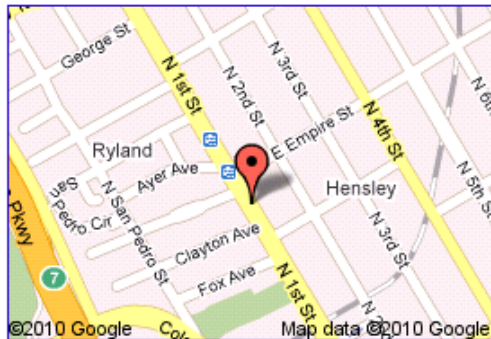

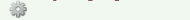
