- 1 PROCEEDINGS
- 2 (10:05 a.m.)
- 3 CHAIRMAN LEVI: Why don't we start with number
- 4 4 only because that's something you can present, Wendy,
- 5 and doesn't really involve the board yet, and see if we
- 6 get anybody else to join. And then we can go to 2.
- 7 MS. RHEIN: Sure. You all will remember that
- 8 last year we started talking about the assembly of a
- 9 Leaders Council, a group of individuals from the legal
- 10 community, business community, academia, and partner
- 11 organizations that would be part of a Leaders Council
- 12 to help LSC raise awareness of the crisis in civil
- 13 legal aid, potentially raise funds, help us with
- 14 communications initiatives as well.
- We have started the process of asking people
- 16 to join the Leaders Council, to have an initial cohort
- 17 of individuals for 2015 to 2017. And more information
- 18 will be coming about that in the April meeting as well.
- But previously we had provided you a list of
- 20 people that we would want to be considered. You had
- 21 approved that list. And we're working off of that list
- 22 to begin to invite individuals.

- 1 CHAIRMAN LEVI: Good. We're planning to
- 2 announce it at the White House forum, I think Wendy
- 3 just said. And Wendy, I don't know if you -- did you
- 4 want to say anything about leadership of it?
- 5 MS. RHEIN: Yes. So Harriet Miers has agreed
- 6 to be a co-chair of the Leaders Council. And
- 7 there -- and John --
- 8 CHAIRMAN LEVI: Yes. We also have people
- 9 who -- thus far, as we ask people to be on it, nobody
- 10 is saying no. We have gotten nobody -- nobody has
- 11 turned us down yet, which is -- and I think about ten
- 12 people have said yes.
- 13 And they understand it's a light ask. We're
- 14 not over-burdening people. But it is part of getting
- 15 the knowledge of our -- really, of LSC's existence and
- 16 what it's up to out there more broadly than just an
- 17 eleven-person board.
- 18 Well, then, I guess we still don't have a
- 19 quorum. And so you want to discuss for a minute the
- 20 board member visits? And Julie, you could, I guess,
- 21 start that by reporting on your -- what happened in
- 22 Puerto Rico. And then I think we should talk about how

- 1 we envision going forward with the board member visits.
- 2 MS. REISKIN: Okay. Sure. So at the NLADA
- 3 meeting, Jim and I at least present to client leaders.
- 4 And then usually I do some other training as well.
- 5 And as a result of that, the representative from the
- 6 Puerto Rico program told me about this great client
- 7 assembly that they have every year where they have
- 8 clients from -- their program's a statewide or
- 9 territory-wide program, and it's broken out into
- 10 regions. And each region has a client council, and
- 11 those client councils elect people to serve on the
- 12 board of directors as a client rep.
- 13 So anyway, they have this assembly every year
- 14 where they get people together, and it's mostly a
- 15 training thing for the client members. And he invited
- 16 me to that. And Jim and I talked, and we decided
- 17 that -- well, we both agreed that it would be not a
- 18 good idea for me to do this visit with LSC funds
- 19 because we don't want anyone saying that members are
- 20 taking a vacation to a resort or anything.
- 21 But a local foundation that I work with is
- 22 very invested in client engagement, and they actually

- 1 had already put aside money for learning journeys. So
- 2 they covered the cost of it.
- And so I went, and it was an incredible visit.
- 4 I met with a number of different clients. I attended
- 5 the client assembly, which was just incredible. They
- 6 had a hundred or so clients there. They had the leader
- 7 of the bar, the current president of the bar, the past
- 8 president of the bar, and then on video, their
- 9 congressman spoke to the group.
- 10 I was very impressed with how they handled the
- 11 training. For example, they trained clients on the
- 12 restrictions, but then they also intermingled it with
- 13 fun stuff, like they had a mariachi band come in, or a
- 14 particular client who'd done a whole bunch of work.
- 15 I got to meet with a lot of clients in
- 16 different -- including I went to one of the villages
- 17 where they're doing some housing work, and got to
- 18 really see the impact of the work our program's doing.
- 19 I also got to meet with some members of the board to
- 20 hear about just some of the challenges that they're
- 21 having. It was really an incredible business.
- They were very, very welcoming. They were so

- 1 excited that I was there, just so excited. But the
- 2 program, the board -- the executive director spent a
- 3 lot of time with me, but the other staff, it was more
- 4 like an hour here with different -- like probably no
- 5 one staff person spent more than a couple hours at
- 6 different times.
- 7 And the executive director, I kept saying,
- 8 "You don't have to spend so much time with me," because
- 9 I didn't want to interfere. But she seemed to really
- 10 want to. And again, they were just so excited about
- 11 this.
- 12 So I felt like I learned more going as an
- 13 individual, just -- it wasn't like a visit where they
- 14 put on kind of a -- I don't want to say this in a
- 15 negative way, but like a dog and pony show for us. It
- 16 was very -- it was a lot more organic and just
- 17 something I would -- I learned so much more about the
- 18 program, and how it really plays out in real life, and
- 19 the real impacts on people, than I've ever learned
- 20 doing the kinds of visits that we do, not that I think
- 21 those are bad in any way.
- I just think there's a lot to be said for one

- 1 person, an individual or even maybe two people, just
- 2 going, talking to people, and seeing it in that very
- 3 different way. And again, they couldn't have been more
- 4 gracious and more excited about it.
- I am working on a written report that of
- 6 course you'll all get. I just haven't gotten it done
- 7 yet.
- 8 CHAIRMAN LEVI: Well, I just wanted to comment
- 9 to say thanks, Julie, for going and for raising the
- 10 money, actually, to pay for it. I also want to say,
- 11 though, that in my own vision of the board member
- 12 visits, while board member education is certainly
- 13 important, it's really also part of an effort to narrow
- 14 or -- there's 15 to 18 years between our visits to a
- 15 particular state, if you follow the spindle around and
- 16 we have three of them a year.
- 17 And that's a long time. And the issue of how
- 18 do we cause the local folks to remember who we are,
- 19 what we are, why we exist, know us a little bit better
- 20 and we them -- so that's part of -- and so one of the
- 21 things that we were particularly interested in is
- 22 having LSC's management's own take on this without

- 1 over-burdening them because we are, we know, an active
- 2 board.
- It's to come up with some sort of ideas of how
- 4 we could structure this effort that wouldn't overwhelm
- 5 everybody and could leave, as a legacy matter, kind of
- 6 a way of doing this that, over time, would accomplish
- 7 the objective of getting us out there more, but also
- 8 would be helpful to LSC in a larger way.
- 9 I don't know. Jim, do you want to sort of
- 10 discuss a few of the items that you thought would be
- 11 helpful? Or do you want me just to do that?
- 12 PRESIDENT SANDMAN: I'm happy to do it, John.
- 13 So we've thought about how we might go about this in a
- 14 way that accomplishes our strategic objectives of
- 15 raising awareness of civil legal aid and of LSC itself,
- 16 calls attention to the good work that our grantees are
- 17 doing, and demonstrates the constituent service that
- 18 grantees provide with federal funding.
- We're doing several things here. We're
- 20 starting by compiling a list of grantees that we know
- 21 board members have already visited or that I have
- 22 visited. Then we're going to survey the board to be

- 1 sure that we've captured all of their grantee visits on
- 2 our list.
- 3 Then we'll look at those programs that have
- 4 not had a visit and identify candidates using several
- 5 criteria. Our criteria would include trying to connect
- 6 the visit to a newsworthy hook such as the announcement
- 7 of a technology initiative grant or a Pro Bono
- 8 Innovation Fund grant, a significant speaking
- 9 opportunity, or a connection that the location has with
- 10 one of our nine privately funded projects.
- 11 Another criterion would be seeking grantees
- 12 that are enthusiastic about the visit and capable of
- 13 supporting it on the ground. For example, we'd like to
- 14 look for grantees that are well-connected with their
- 15 local media and with their members of Congress and have
- 16 interesting programs to highlight.
- We'd like to seek opportunities to engage with
- 18 the local member or members of Congress and schedule
- 19 the visit at times when the member is likely to be in
- 20 the district. We'd like to look for opportunities to
- 21 engage in collective --
- 22 CHAIRMAN LEVI: Wait a minute. Jim, can I ask

- 1 you --
- 2 PRESIDENT SANDMAN: Yes?
- 3 CHAIRMAN LEVI: Jim, can I just stop for a
- 4 second? I got an email from Frank Strickland that he
- 5 can't dial in. Are others -- did you receive that from
- 6 anybody else?
- 7 MS. RHEIN: No. But I think that several
- 8 people might have joined.
- 9 FATHER PIUS: Yes. I'm on now. My apologies
- 10 for being late.
- 11 CHAIRMAN LEVI: Okay. That's Father Pius.
- MS. RHEIN: Hi, Father Pius.
- 13 CHAIRMAN LEVI: Well, does somebody want to
- 14 reach out to Frank Strickland? I didn't mean to
- 15 interrupt Jim, but I think you'll understand.
- MS. RHEIN: Sure.
- 17 CHAIRMAN LEVI: I apologize for that.
- PRESIDENT SANDMAN: Oh, no problem.
- 19 CHAIRMAN LEVI: Should I just try to
- 20 conference him in somehow or --
- 21 MS. RHEIN: No. Katherine's going to help him
- 22 out.

- 1 CHAIRMAN LEVI: All right. Thank you. And
- 2 Jim, proceed. I'm sorry.
- 3 PRESIDENT SANDMAN: We'd like to look for
- 4 opportunities to engage with collaborators like judges,
- 5 state access to justice commissions, bar associations,
- 6 and law schools. And finally, we'd like to find, if we
- 7 can, connections between the visiting board member and
- 8 the location, such as programs that are near the board
- 9 member's homes or where the board member went to
- 10 school, something that will give a connection so we can
- 11 leverage it in scheduling activities.
- 12 Finally, I think we should be open to the
- 13 kinds of events that Julie mentioned, preexisting
- 14 events that the grantee has already scheduled but that
- 15 they would be happy to have us piggyback on. So, say,
- 16 after we come up with our broad list of programs that
- 17 haven't had a visit, our suggestion is that we use
- 18 these criteria to identify where we might start.
- 19 CHAIRMAN LEVI: That's great. I think that's
- 20 very helpful.
- 21 MS. REISKIN: Yes.
- 22 CHAIRMAN LEVI: I would also say -- I'm sorry?

- 1 MS. REISKIN: This is Julie. I'd really like
- 2 to encourage that last one because what was so
- 3 meaningful to them in terms of kind of the goodwill was
- 4 that someone from LSC came to their thing, that we
- 5 cared enough to join them at something that was very
- 6 important to them.
- 7 And while it was a client assembly, I mean,
- 8 the whole state -- the bar was involved. The whole
- 9 staff. It's a big event for them. And the fact that
- 10 they kept saying, "We're so glad that you guys cared
- 11 enough."
- 12 CHAIRMAN LEVI: I also think, with Wendy's
- 13 advice, and others may know, that when you are in a
- 14 particular area, there may be law firms headquartered
- 15 there, or businesses, or opportunities for visits on
- 16 the potential for support side and outreach.
- 17 And we want to be careful, obviously, that we
- 18 don't upset our grantees about that. But it is
- 19 important that -- again, one of the things that's just
- 20 struck me so when I've gone to some of these places
- 21 around the country and met with law firm leaders, is
- 22 how little they know about LSC.

- 1 And it doesn't even have to be that the
- 2 meeting is to raise money. It's just coming in to say
- 3 who we are and what we're doing, and we just need them
- 4 to be aware of our existence and how important we are
- 5 to the ordinarily functioning of the justice system.
- 6 So there's an opportunity for other kinds of
- 7 outreach on a more directed basis that I think, Wendy,
- 8 you and your team would -- but the board member may
- 9 also have contacts or know folks in the area. But I
- 10 think that could be helpful, too.
- I think we now have a quorum. So if we do, I
- 12 can formally call the meeting to order and say that it
- 13 was duly noticed, and ask that we have an approval of
- 14 the agenda.
- 15 MOTION
- MS. REISKIN: So moved.
- 17 CHAIRMAN LEVI: Second?
- 18 FATHER PIUS: Second.
- 19 CHAIRMAN LEVI: We just had a report from
- 20 Wendy on item number 4. And we also are in the midst
- 21 of the discussion of item number 2.
- Is there more discussion on that that anyone

- 1 else -- Martha, do you want to say anything about it?
- DEAN MINOW: No, no.
- 3 CHAIRMAN LEVI: Okay. And any other questions
- 4 about that? Father Pius?
- 5 FATHER PIUS: No. I'm good. Thank you.
- 6 CHAIRMAN LEVI: Okay. And did Robert Grey or
- 7 Frank get on the phone?
- 8 MR. STRICKLAND: Frank is on. I was dialing
- 9 the wrong number. It was my mistake. My end.
- 10 CHAIRMAN LEVI: That's all right. So the
- 11 action item that we actually need a vote on is number
- 12 3. There was a cy près award that was given to LSC
- 13 based on the settlement or resolution of a class action
- 14 here that my firm was involved in. And for very nice
- 15 reasons, the court decided to allocate \$43,155.20 to
- 16 LSC. And so we have made a recommendation, which I
- 17 think you've received, that this award be designated
- 18 for use in connection with the justice gap report study
- 19 that we're conducting. And so that means a vote of the
- 20 committee. And if we could have a motion. Does it
- 21 need a motion, Ron?
- MR. FLAGG: Yes. Yes, you should have a

- 1 motion to approve the allocation, as set forth in the
- 2 printed request that was part of the agenda.
- 3 CHAIRMAN LEVI: Could somebody so move?
- 4 MOTION
- 5 FATHER PIUS: So moved.
- 6 CHAIRMAN LEVI: Second?
- 7 MR. STRICKLAND: Second.
- 8 CHAIRMAN LEVI: All in favor?
- 9 (A chorus of ayes.)
- 10 CHAIRMAN LEVI: Okay. Any public comment?
- 11 (No response.)
- 12 CHAIRMAN LEVI: Any other business?
- 13 (No response.)
- 14 CHAIRMAN LEVI: Well, in fairly record time,
- 15 we can have a motion to adjourn.
- 16 MOTION
- 17 DEAN MINOW: So moved.
- 18 MR. STRICKLAND: Second.
- 19 CHAIRMAN LEVI: All right. See you all in
- 20 Washington.
